## ELIGIBILITY

1. There is no limit to the number of buildings a property management firm or owner may enter.
2. The building must be owned or managed by a BOMA Calgary member.
3. The building must be at least one year old from the date of occupancy of the first tenant by January 2011.

## RECOGNITION

The BOMA Calgary Earth Award will be presented at the BOMA Calgary Celebration of Excellence in May.

## TO ENTER

Entrants are asked to forward a completed Earth Award registration form. Once received, entrants will be provided with a Submissions Guidebook outlining details of the formal submission. Formal submissions must be received by 4pm, March 12, 2011.

## EARTH AWARD

The Earth Award is BOMA Calgary's opportunity to recognize and promote "environmental stewardship" in the building industry. The title "Earth" recognizes Earth Day which is celebrated to raise awareness of environmental issues.

The 2010 Earth Award has been designed to align with BOMA Canada and BOMA International Earth Award program requirements.

All entries will be subject to a site visit and verification process.

Having achieved BOMA BESt of level 1 or higher is mandatory for entry.

Applicants are required to submit a binder. BOMA BESt binders may be used as the foundation for the Earth Award, but please pay attention to the different requirements, particularly in the OH&S sections.
